Greeting!

WHEREAS it is Our Will and Pleasure, We do hereby nominate and constitute and appoint you Alan George Blair Esquire to be Our Receiver General during Our Pleasure in and for Our Island of Jersey for carrying on all financial business connected with the receipts and expenditure belonging to Our Ancient Domain in the said Island of Jersey, for Us and in Our name to ask, demand, and receive all rentes now due and that shall or may at any time become due to Us, either in money or in kind, and also all tithes, and all fermes, comparts, escheats, successions, renunciations, royalties, wrecks of the sea, gravages, and casualties and all Seignorial dues whatsoever, and all penalties, fines and amerciaments, and generally all other Revenues and Dues whatsoever either annual fixed or casual now owing, and that shall or may become due or owing to Us, in the said Island of Jersey, and accruing and accrued out and by reason of Our said Ancient Domain therein; and also, under the directions of Our Lord Chancellor through Our Lieutenant Governor of Jersey, to let all such houses, mills, buildings, lands, tenements and hereditaments as now belong and shall or may belong unto Us in the said Island, being part and portion of Our said Ancient Domain there, and to execute all leases concerning the same, and to demand and receive all the rentes and profits thereof, and to give and execute all receipts and discharges as shall and may be needful and necessary; And, under such directions as aforesaid, to enter into any negotiations for, and to carry out and effect, the sale, exchange, commutation, or alienation in any manner of any rentes, tithes, rights or dues and of any houses, mills, buildings, lands, tenements and hereditaments belonging or which shall or may belong to Us in the said Island forming part of Our said Ancient Domain; And, under such directions as aforesaid, to purchase and acquire any rentes lands and real estate whatsoever for Us and in Our name in the said Island for the purpose of being added to Our said Ancient Domain or otherwise dealt with for our benefit and service; And further, under such directions as aforesaid, to pay all rentes due on account of the several properties belonging to Us in the said Island and generally make all such payments as may be required to be effected in Our name or for Our service in the said Island; and generally to do and perform all acts and things which may be required for the due execution of the Office of Our Receiver General in Our said Island. And to promote and defend Our rights title and estates and to carry on judicial proceedings and matters at Law connected therewith or required or needful for the protection of Our rights of property and Revenue in the said Island now commenced or to be commenced sued for or defended as provided by the Laws and Customs of Our said Island of Jersey. And to pass and execute all contracts and deeds which may be required to be passed before the Royal Court of Our said Island of Jersey for any of the purposes aforesaid. And you are to make out and render for audit just and true accounts of all your receipts and expenditure, and to transmit all balances to

Our Paymaster General, and to report fully from time to time as shall be required by Our Lord Chancellor and to conform yourself to his instructions and directions respecting matters and things relating to the properties aforesaid and to the management and interest of the same. Provided always and Our Will and Pleasure is that you the said Alan George Blair shall cease to be Our Receiver General in and for Our Island of Jersey and this Warrant shall cease to have effect on the Nineteenth day of June in the year of Our Lord Two thousand and thirty-two. And in case of your sickness or absence from the said Island We do hereby also nominate and constitute and appoint the Chief of Staff to the Lieutenant-Governor of Jersey or any such person as you the said Alan George Blair may consider suitably qualified to hold the Office to act during Our pleasure without further instrument or other approbation from Us in your stead respecting the matters aforesaid during such sickness or absence from the said Island.

And for so doing this shall be your Warrant.
